

Town of Ledgeview Park and Recreation Committee  
September 18, 2014

The Ledgeview Park and Recreation Committee held a meeting on June 19, 2014 at the Ledgeview Town Hall located at 3700 Dickinson Road, De Pere WI 54115.

The meeting was called to order at 6:06 p.m.

Members present were Steve Krueger, Nicole Van Helden, Larry Sidman, and Sarah Burdette (Town Clerk/Administrator). Jason Shanda and Phillip Danen were excused.

AGENDA APPROVAL: Motion by Sidman to approve. Seconded by Van Helden. Motion carried.

APPROVAL OF MINUTES: Motion by Sidman to approve, seconded by Krueger. Motion carried.

PUBLIC COMMENT: None

COMMUNICATIONS:

1. Update on public-private concept project near Scray Hill Park. Application has been rescinded.

OLD BUSINESS:

1. Recommendation on appointments to Beautification Committee. Van Helden began contacting interested volunteers and is waiting to hear back from most. She would like to have a committee size of 5. Appointments will be made at the October Park and Rec meeting.
2. Update on ice skating rink activities. Sidman met with Town Public Works staff about possible outdoor ice skating rink locations. Staff recommended the Ledgeview Park parking lot near the baseball diamond. Entrances would be blocked off, and the lot would be flooded. Motion by Sidman to recommend to the Town Board creating an ice arena at Ledgeview Park. Seconded by Krueger. Motion carried.

NEW BUSINESS:

1. Review agreement between Town of Ledgeview and De Pere Baseball regarding improvements. Agreement was distributed and reviewed. Town Board approved on 9/16/2014.
2. Review draft 2015 Park and Recreation Budget. Budget for Park Committee and Beautification Committee was provided.

PARK & RECREATION PLAN: Jeff Sanders distributed and gave a presentation on the draft Park and Recreation Plan, including results from the mapping exercise.

Jeff requested that the Park and Recreation Committee review/provide feedback, especially on the following:

- Review "2015 Inventory of Ledgeview Parks, Trails and Open Space" map and provide updates/corrections. Source of map is 2007 Plan.
- Agreement/disagreement on "2015 Proposed Park Locations" map which comes from the 2007 plan.
- Review "Existing & Proposed Bicycle & Pedestrian Facilities" map.
- From plan, review accuracy of Existing Park Facilities (pg. 20-21), Current Facilities table (pg. 63) and Facilities Shortfall (pg. 65).
- Overall comments on plan
