
PLEASE TAKE NOTICE that the Town of Ledgeview located in Brown County, Wisconsin has declared its intention to exercise its police powers under Chapters 60 and 66, Wisconsin Statutes, to levy special assessments to property abutting upon CTH GV (Monroe Road), Oakridge Circle, Ledgeview Road, and along with adjacent areas, said improvements upon said property to be curb and gutter, trail/sidewalk, and storm sewer. The assessment area is further identified as shown on Exhibit A attached hereto and made part of this notice.

The report of the Town Engineer for the Town of Ledgeview showing final plans, and an estimate of the entire and complete cost of installation and construction and the proposed assessments, is on file in the office of the Town Clerk for Ledgeview at 3700 Dickinson Road, De Pere, Wisconsin. Said report may be inspected at the office of the Town Clerk on any business day between the hours of 8:00 a.m. and 12:00 noon, 1:00 p.m., and 3:00 p.m.

YOU ARE FURTHER NOTIFIED that the Town of Ledgeview will hear all persons interested, or their agents or attorneys, concerning the proposed special assessment at 6:00 p.m. on the 1st day of December, 2014, in the Town of Ledgeview Municipal Building located at 3700 Dickinson Road, DePere, Wisconsin. All objections will be considered at said hearing, and thereafter, the amount of any final assessment (if any), will be determined by the Town pursuant to any final resolution levying special assessments as voted upon and passed by said Town.
