June 3, 2015

The Ledgeview Park and Recreation Committee held a meeting on June 3, 2015 at the Ledgeview Town Hall located at 3700 Dickinson Road, De Pere WI 54115.

The meeting was called to order at 6:05 p.m.

Members present were Nicole Van Helden, Larry Sidman, Jason Shanda, Joe Widi and Cullen Peltier. Steven Krueger was excused. Sarah Burdette (Town Clerk) and Dustin Wolff (Planning consultant from Mead & Hunt) were present.

AGENDA APPROVAL: The agenda was approved as provided.

APPROVAL OF MINUTES: Motion by Sidman to approve minutes as provided, seconded by Van Helden. The motion carried. Widi and Peltier abstained.

PUBLIC COMMENT: None

COMMUNICATIONS:

1. Beautification Committee update: Motion by Van Helden, seconded by Shanda to appoint Mary Handrick and Kari Willmott to Beautification subcommittee. Motion carried.

Van Helden provided an update on Beautification committee business, including banners and banner sponsorship. Sidman recommended checking Town ordinances regarding sponsorship rules. Park and Rec committee supports continued exploration of geocaching opportunity in a park. Committee also supports additional beautification projects to engage community members.

PARK & RECREATION PLAN:

1. Continue progress and discussion on Park & Recreation Plan Update.
Committee reviewed progress to date. Request made by planner for the Committee to do the following before the July 21st meeting: a) review Chapter 3 to ensure goals, objectives and strategies are reflective of the committee's desires, b) mark up Map 3 with preferred routes (text will include action items for next steps (e.g. engineering plan for feasibility, etc), c) review Map 4 (dots are from previous plan, is committee happy with those? Where in general should pocket, neighborhood or community parks be located?), d) review pages 61-66 (from the existing park plan), e) send Chapter 6 comments to Sarah, and f) look at page 75 (what do existing parks need?). Dustin or Sarah can answer questions, take comments.

Dustin will share a future land use map for use during plan review and ask Sarah to share Dropbox site with committee.

At the next meeting, we will identify a schedule for plan completion.

ADJOURNMENT: Motion by Van Helden, seconded by Widi to adjourn meeting at 8:16 p.m. The motion carried unanimously.
