Demarcating Public Lands: Need clarity on what is being requested. Some initial thoughts discussed included:

- 1) Access Points: Use signs
- 2) Borders: Use split fence sections spread out to define where public and private land meet.

Displaying Public Art & Student Involvement: Nicole brought list of ideas she found. The committee liked the idea of displaying student art during voting. The committee also realized that a public art program could include things like music and/or performances in parks. Will discuss more in January.
